# Learning Objectives:

## **1.6 Active-Duty Education Benefits**

a. Identify the primary and secondary benefits of the Post 9/11 GI Bill

- i. Must have served 90 continuous days to be eligible for some benefit but minimum 36 months of service to be eligible for 100% benefit.
- ii. Maximum 48 months of benefits
- iii. VA will pay the equivalent of the highest in state public university tuition plus a housing allowance and book stipend.

#### Exercise 1: GI Bill Benefits

List the primary and secondary benefits offered by the Post 9/11 GI Bill for eligible active-duty service members.

- b. Explain how the housing allowance portion of the Post 9/11 GI Bill works
  - i. Allowance amount based on rate for E-5 with dependents using the school's zip code to determine duty location
  - ii. Allowance paid monthly and is tax free

#### Exercise 2: Housing Allowance Calculation

Explain the process of calculating the housing allowance portion of the Post 9/11 GI Bill and factors that may affect the amount received.

- c. Discuss the book allowance and demonstrate methods to maximize the book allowance benefit
  - i. Post 9/11 GI Bill annual non-taxable book allowance up to \$1000 (2023) depending on number of credits

#### Exercise 3: Book Allowance Benefits

Describe the book allowance benefit provided by the Post 9/11 GI Bill and suggest methods for maximizing this benefit.

d. Contrast Tuition Assistance, the Montgomery GI Bill, and the Post 9/11 GI Bill

- i. Tuition assistance is education benefits paid directly by the military branch instead of the VA while the service member is on active duty. Coursework must be directly related to servicemembers military career
- ii. Eligible for Montgomery GI Bill after serving continuously for 3 years (2 years if that is agreement on enlistment contract) and having 12 months of deductions of \$100 month from military pay in the first year of service. Maximum 48 months of benefits. VA makes payment for tuition directly to the school
- iii. Eligible for 100% of benefits for Post 9/11 GI Bill after serving for 36 months (lower percentage of benefits if served less than 36 months). No payment required. VA makes payment for tuition directly to the school. Housing allowance paid while school is in session
- iv. Must choose either Montgomery GI Bill or Post 9/11 GI Bill. Can not use both education benefits. Receiving Tuition Assistance does not impact use of VA education benefits

Create a table comparing Tuition Assistance, the Montgomery GI Bill, and the Post 9/11 GI Bill, including eligibility criteria, benefits, and limitations.
